I anticipate that this discussion will focus on the forum feedback, annual meeting feedback and next steps.</p> <ul style="list-style-type: none"> • I met with the Pittsburg staff and two board members on March 4th. Much of their concern was on representation, unanswered questions, and student opportunities. It is clear that the Pittsburg staff is proud of Pittsburg School. They feel strongly that students are treated fairly and provided many opportunities while in attendance. • Please keep in mind that the Professional Development day is scheduled to be held on March 22nd in Pittsburg. Nicole Highmark from NHSBA will review the Code of Ethics and the Code of Conduct with staff members from all four schools. • Raymond Lacasse has been hired as the JV baseball coach for Pittsburg/Canaan. He is all set to begin participation with the athletes once the season begins. I had a chance to meet Mr. LaCasse at the Pittsburg annual meeting and he is excited to have this opportunity. • There is a lot going on in the legislature right now. Please keep an eye on the emails that are coming from NHSBA and if the board ever wants to send testimony on any of the bills, please let me know and we can put something together and send it along. Recently there has been a push to submit testimony on the Learn Everywhere initiative that is being spearheaded by Commissioner Edelblut. I will share more at the board meeting. I will be attending the North Country Superintendents meeting in Haverhill on Thursday, March 14th.
